I agree freely to this waiver in consideration of my child being allowed to participate in Ultimate Frisbee ("Ultimate") functions of Bellingham Youth Ultimate ("BhamYU").

Assumption of Risk & Medical Authorization

I understand Ultimate is a physical activity involving considerable running and jumping. I understand that collisions between players or with sideline obstacles or the ground can occur. I understand that a single field of play can include participants of both genders ranging in age from early childhood to late adulthood. I recognize that Ultimate is dangerous, with inherent risks including, but not limited to, those identified above, with consequences ranging in severity from minor scrapes or strains to serious injury, permanent disability, or death. I assume and accept the known and unknown risks related to my child's participation in BhamYU activities. I accept my responsibility to be informed, to encourage my child's prudent and safe behavior and play, and to read and abide by all reasonable and available sources of information about the activities. I am familiar with my child's health status, fitness level, and skill, and I believe my child is physically qualified to participate safely in BhamYU activities. If my child becomes injured or ill, and I cannot be contacted, I give permission to qualified and licensed EMTs, physicians, paramedics, athletic trainers, and/or other medical or hospital personnel to render treatment.

Indemnification and Release of Liability

On behalf of myself and my spouse, heirs, personal representatives, assigns, and next of kin, I hereby release BhamYU and its employees, directors, officials, sponsors, contractors, insurance carriers, equipment suppliers, officers, volunteers, other participants, and lessors of property used to conduct the events ("Releasees") from any and all claims for injury, loss, or damage to person or property incident to my child's involvement in or travel to and from BhamYU programs, whether arising from the negligence of the Releasees or otherwise, to the fullest extent permitted by law. On behalf of the same, aforementioned parties, I hold harmless and indemnify all above Releasees from any and all liabilities incident to my child's participation, even if arising from the Releasees' negligence. I will reimburse the Releasees for all medical expenses, legal costs, attorney fees, court costs and investigative costs incurred as a result of my child's participation in or travel to and from BhamYU activities, personal claims arising out of an injury to my child, or claims of co-participants, rescuers and others arising from the conduct of my child during participation.

Media Release

I understand that pictures, video, and audio recordings of my child may be taken at BhamYU events. I hereby agree that BhamYU may use recordings of my child for publicity, promotional, educational, and youth fundraising materials. Examples include but are not limited to social media like Facebook and Twitter, event programs, and press releases. I understand that BhamYU will not sell any recordings of my child without my express permission.
